Focus on Art for Social Transformation. Art is a right A catalyst for Political, Economic, Social and Environmental Development



Leading social organizations of art and culture in Europe and Latin America will meet during working sessions to debate about the importance of art in processes of social development and intercultural construction. Discussions will also include the visions of multi-sectorial international referents.

The Latin Network of Art for Social Transformation and Expedition Metropolis - Creative Cooperations, have decided to join efforts in the organization of the *Working sessions: Focus on Art for Social Transformation. Art is a Right. A catalyst for Political, Economic, Social and Environmental Development* to exhibit the role of art and culture in social development in Europe and Latin America.

This multi-sectorial symposium on the role of art and culture in social development aims to continuously amplify and deepen the dialogue between Europe and Latin America: dialogue that encompasses both critical reflections and joint actions.

Artists engaged in youth and community empowerment, social leaders, researchers, private companies, foundations, politicians and other experts will be invited to exchange ideas and interpretations on the current and potential bridges that exist between art and other sectors and on its role in generating positive changes for a more sustainable society.

# Objectives

• Give visibility and deepen the understanding of the role of art and culture in social development.

• Generate connections between European and Latin-American organizations dedicated to art and community processes.

• Increase the comprehension of AFST and explore conclusive ways of integrating global issues in local views and programs.

• Draft a Mutual Understanding Document about the offers and contributions of art for social transformation organizations for the global agenda.

• Develop a crossed agenda 2009-2011 of LA-European art for social transformation projects that includes a platform of dialogue and LA-EU exchange applied to a public global cause.

# Driving Concepts

# **1.** Evolving from Exchange to "pooling" experiences.

As opposed to traditional models of exchange (receiving support from others or offering help to others) we aim to explore ways to pool experiences, practices, views and interpretations.

- Cross-Atlantic: Cross-cultural transfer within AFST.
- Cross-sector: Potential with other initiatives on social development.

## 2. Evolving from building bridges towards common territories.

As opposed to merely connecting distanced realities by building bridges between them, we aim to explore common territories. To avoid theorizing, we will try to create innovative prototypes that must reflect the potential to pool experiences towards bettering the impact.

• <u>Prototyping</u> – designing possible joint endeavours and outlining how they might (1) capitalize existing experiences, (2) pool experiences, practices, views and interpretations from Europe and Latin America, and (3) generate concrete benefits for stakeholders.

## 3. Evolving from particular demands towards shared needs.

As opposed to habitual demand-based funding proposals (financing), we aim to explore shared needs of both the organizations and their existing and future donors and supporters (capitalizing).

 <u>Capitalizing Art for social transformation</u> – We aim to develop a new matrix permitting us to unearth, correlate and interpret the underlying needs of the beneficiaries, the organizations and the donors. This will lead us to formulate proactive value proposals, which also address the needs of our donors and the "return on investment" for the social investor.

# Working Dynamics

Working sessions will include approximately 40 participants from Latin America and Europe.

The working sessions will be held according to the following structure:

- They will start-off with kick-off presentations outlining the dilemmas and potential common grounds for joint construction.
- Following these kick-off presentations, participants will break up into 6 groups that will work around a set of questions and propose a series of solutions. Each group will have an assigned reporter that will register group conclusions.
- The conclusions of each group's work will be debated among the entire group which later will make gradual contributions to a Mutual Understanding Document/Common LA-Europe Action Plan.

These dynamics have been designed to allow every participant to take an active role in the discussion.

The construction of connections between both regions will be facilitated with a group discussion that looks for:

## Knowing what exists

- To map out the territories of action and what we will discover and practice in art and social transformation in both regions.
- To gain knowledge of activities of exchange which already exist between Latin America and Europe.
- To explore the actual or potential capacities of the organizations according to the subject of interaction with others, connectivity, inclusion of diversity, associated processes, work in thematic and/or territorial networks, and strategies for working outside of global and local borders.
- Discover which are the projects that search to give answer to the demands and needs of the global society and the manner in which they are making this contribution visible.

## Creating something new

- Defining the new territories for combined action, ideas, strategies and actions which will be developed to fortify the capacity for interaction between Europe and Latin America.
- Exploring the present extent and the potential of dialogue and combined actions with other developmental sectors such as the world of economics, education, environmentalism, sports, government and human rights, learning the opinions of experts regarding the contributions of art to the crisis of the financial system, the economy and the environment.

- Defining together with the representatives of financial organizations the main issues regarding the financing of these developing programs and the offers made by these organizations to these investors.
- To meet with different development actors equitably in order to agree on a common understanding of the problem which we face from different spheres: therefore the task of producing answers to these problems is between all spheres as well.

Creative Cooperations is a European network of youth arts projects. A total of 14 partners from 9 European countries, have come together and agreed on a programme of concerted action. Creative Cooperations was founded under a mandate from the European Commission and on the initiative of the Schlesische 27 international culture centre in Berlin. Creative Cooperations was initially selected as a pilot network for the European Voluntary Service youth programme and has since won recognition as a multilateral network.
